

## Personal Data Processing Notice

### What is KVKK?

The Personal Data Protection Law No. 6698 (“KVKK”) entered into force on 07.04.2016 and aims to protect the confidentiality of personal data, prevent unlawful access, and ensure the secure processing of data.

As Atak Domain Bilgi Teknolojileri Anonim Şirketi, we adopt the protection of personal data as a fundamental principle in all services we provide.

### What is Data Processing?

All operations performed on personal data — such as recording, storing, preserving, updating, classifying, transferring, deleting, destroying, and modifying — are considered “data processing.”

### Who is the Data Subject?

Any real person whose personal data is processed.

### Who is the Data Controller?

The person or entity that determines the purposes and methods of processing personal data.

In this context, Atak Domain Bilgi Teknolojileri Anonim Şirketi is the “data controller” for our customers, users, visitors, and employees.

### Who is the Data Processor?

Real or legal persons who process personal data on behalf of the data controller. Suppliers, business partners, and service providers working with our company may fall under this definition.

### 1) Data Controller and Representative

In accordance with KVKK, your personal data is processed by Atak Domain Bilgi Teknolojileri Anonim Şirketi as the data controller.

### 2) Collection, Processing and Purposes of Processing Personal Data

Your personal data is processed under Articles 5, 6, 8, and 9 of the KVKK for the

purposes of providing our services, carrying out user operations, establishing and performing contracts, fulfilling legal obligations, and delivering customer support.

Processed data categories include:

Identity Information

Contact Information

Location Data

Customer Transaction Information

Risk Management Information

Financial Information

Visual and Audio Records

Physical Venue Security Data

Transaction Security Data (IP address, log records, etc.)

Marketing Data

Your data is processed for the following purposes:

Provision of services and account management

Domain registration, renewal, and transfer operations

Hosting, email, server, and security services

Execution of financial transactions

Responding to support requests

Fulfillment of legal obligations

Management of abuse and security processes

Improvement of user experience

Responding to requests from official authorities

### **3) Parties to Whom Personal Data May Be Transferred and Purposes of Transfer**

Your personal data may be transferred in accordance with Articles 8 and 9 of KVKK to the following parties:

Business partners, suppliers, technical service providers

Payment service providers

Domain registry operators (Registry/ICANN processes)

Domestic and international business partners

Lawyers and consulting firms

Authorized public institutions and organizations

Judicial authorities and law enforcement agencies

Such transfers are carried out strictly in compliance with applicable legislation and KVKK provisions.

### **4) Method and Legal Grounds for Collecting Personal Data**

Your data may be collected through:

Website, customer panel, mobile interfaces

Call center, email, support requests

Contracts and digital forms

Payment systems

Cookies and analytics tools

Automatic logging systems

Legal grounds include:

Establishment or performance of a contract

Atak Domain's legal obligations

Legitimate interests

Explicit consent (when required)

Establishment, exercise, or protection of a right

### **5) Retention Period of Personal Data**

Your personal data is retained:

For the duration required by applicable legislation

For as long as contractual processes continue

When the legal retention period expires or the purpose of processing ceases, your data is:

Deleted

Destroyed

Anonymized

As a rule, destruction is completed within a maximum of 24 months after the retention period ends.

### **6) Your Rights Under KVKK (Article 11)**

You have the following rights:

To learn whether your personal data is processed

To request information regarding processing

To learn the purpose of processing and whether it is used accordingly

To know the third parties to whom data is transferred

To request correction of incomplete or inaccurate data

To request deletion or destruction of data

To request notification of such actions to third parties

To object to results arising from automated analysis

To request compensation in case of damage
